#### **Country Profile: FGM in Nigeria.**

In Nigeria, the estimated prevalence of FGM among women aged 15 to 49 is 24.8% (DHS 2013, p 348). 20 million women and girls in Nigeria have undergone FGM. This represents 10% of the global total. (UNICEF, 2013).

## RESEARCH AND STATISTICS

**Men Speak Out** is a partnership that aims to engage men in the process of ending FGM and, on a larger scale, to end violence against women and promote gender equality through a human rights approach. See [www.menspeakout.eu](http://www.menspeakout.eu)

In December 2016. Men Speak Out launched the preliminary results of their research exploring men's involvement in FGM in Belgium, the Netherlands, and the United Kingdom. *"Across all three countries male and female research participants suggested that communication between men and women was crucial for an abandonment of the practice. On an interpersonal and private level, it is important that husband and wife speak to each other about the practice and discuss the decision not to have their daughters cut. Some suggested that having access to adequate information would make the task easier and that many of those who supported the practice simply 'did not know'. Involving different kinds of leaders, such as religious leaders, opinion leaders and community leaders in the abandonment movement was considered to be beneficial. Furthermore, data from the Netherlands has shown that the information new migrants and asylum seekers receive upon arrival has a strong impact on their attitudes towards the practice. Most men and women said that having more detailed knowledge of the consequences had changed their minds. Information provision for African migrants should no longer remain the responsibility of NGOs and associations but the MSO research shows that receiving such information through a governmental institution and public service may be of benefit and is likely to improve knowledge of the practice and reduce the willingness to continue."*

### **FGM recorded by Health Services in England. July – September 2016**

Cases of FGM recorded by Health Staffs in England from 1<sup>st</sup> July to 30<sup>th</sup> September have been added to the enhanced dataset collection platform. Please note that caution is advised throughout any interpretation of these findings because data completeness is often low and varies by commissioning region and submitter. *The report, covering July to September, shows 1205 newly recorded cases and 1971 total attendances where FGM was identified or a procedure for FGM was undertaken. Almost half of all cases (four in nine) relate to women and girls from London NHS commissioning areas.*

Janet Fyle professional policy advisor at the Royal College of Midwives (RCM) said; *"This latest set of data is most concerning as there appears to be more cases of FGM being identified, particularly in girls under eighteen and those born in the UK. The number of recorded cases in girls under eighteen was 39 cases. There were also 34 newly recorded cases identified in women and girls who were born in the UK. This is simply unacceptable."*

**FGM mandatory reporting: an example to follow?**

**Mandatory reporting of female genital mutilation (FGM) was introduced a year ago in England & Wales. What lessons Scotland might learn from experience there?**

“Any introduction of mandatory reporting in Scotland must take into account the learning from the remainder of the UK. Training and awareness raising for regulated professionals subject to the duty in advance of the mandatory reporting duty is key, as is a need to collect accurate information detailing the outcome of mandatory reports. This information is critical in highlighting whether girls are being safeguarded and protected. Sustained prevention underpinned by a systemic and consistent approach is key.”
